

# BPCL'S SECOND LARGEST SOLAR POWER PLANT SHINES NEAR KOCHI REFINERY

Set in a sprawling expanse of 25.83 acres, Kochi Refinery inaugurated the second largest SOLAR POWER PLANT of BPCL on 17 May 2024, demonstrating our commitment towards sustainability. This 8.4 MWp / 6MW solar power plant is a major step in BPCL's journey towards the NetZero target (Scope-1 & 2) by 2040. The estimated annual electricity generation from this solar plant is 12.48 Million Units, which will reduce nearly 10,235 MT of SCOPE-2 CO2 emissions annually.

With the commissioning of this plant, the Renewable energy portfolio of Kochi has leaped from 525kW to 8925kW. The estimated cost of generation of electricity from this solar project is Rs. 2.76/kwh as against Rs. 5.43/kWh import cost from KSEB. The electricity produced from this plant will result in direct reduction of around 7.9 Crores of electricity bill every year. The estimated IRR for this project is 16.19%.

The Solar power plant was inaugurated by Shri. Sriram S, Chief General Manager (E&AS) on 17 May 2024 in the august presence of Shri. Sankar M, Executive Director, (Kochi Refinery), Shri. Rajeev C, CGM (Operations), Shri. G. R. Senthilkumar, CGM (Tech), Ms Shraddha Jaitly S, CGM (Finance), Shri. T Venugopalm CGM (E&C), Shri. George Thomas, CGM(HR), Shri. Satheesh Kumar K P, CGM (Projects), Shri. Gopalakrishnan M, GM (E&C) and other senior leadership of Kochi Refinery, execution team from E&C Department/HR Estates and owner department P&U-Electrical.

#### From ideation to execution :

Purchased Electricity from Non-Renewable sources accounts for SCOPE-2 emissions and converting it to Renewable power is the solution for eliminating SCOPE-2 emissions. Kochi Refinery imports nearly 307 million units of electricity per year from grid which accounts for nearly 248864 MT of CO2 emissions. With a vision to reduce the cost of electricity and reduce the SCOPE-2 emissions, the Renewable Energy (RE) team identified the vacant marshy land near CISF quarters as a probable location for setting up a solar project. A detailed feasibility study was conducted by the RE team for setting up a 8.4 MWp/6MW solar power plant in this 25.83 acres of land and the investment approval of Rs.39.95 Crores was obtained.





The scope of this project included setting up a ground mounted fixed tilt solar plant, its connected electrical system, structural jobs and associated civil jobs like land filling, land development, foundation jobs, etc. HR team was identified for the land filling/development jobs and E&C team was entrusted with the implementation of this solar plant project with technical support from RE team.

This site offered many challenges during land filling and construction phases, which were surmounted by the dedicated efforts of the execution team. The project cost and time has been optimized by splitting the entire scope into three separate contracts. Land development was done through local agencies utilizing the excess earth available within the refinery. Land development required land filling of approximately 20 acres of land, development of nallah crossing the land, providing coconut piling by the side of the nallah and land adjacent to Chitrapuzha, providing chain link fencing and periphery road.

Power cabling of nearly 9kms from solar plant to New MRS substation inside refinery was executed through the local contractor after retrieving the unused old 33kV KSEB grid incomer cables, which became redundant after the commissioning of 220kV GIS. Setting up of the solar plant within in site boundaries was executed through a solar EPC contractor with 5-year O&M. 3334 Nos of pile foundations of different dimensions ranging from 1.2 to 2.8 m long and 300 to 600 mm dia. were constructed for installing 514 MT of Module Mounting Structures (MMS) and 15556 solar modules. Solar modules of 540 Wp Mono PERC, Half Cut cell mono facial type of WAAREE make are used in this solar project. The other components include 21 Nos 295 kVA string inverters for converting DC to AC, One No. 8MVA transformer for stepping up the voltage from 800 V to 11kV, 2 Nos 4000 A 800 V LT panels, one each of 11kV ICOG/metering panels, 52 kms of DC cables, 12 kms of LT/HT power cables.

The entire journey from ideation to execution of the second largest solar panel farm was completed in less than a year. This is indeed one more giant leap towards NETZERO for BPCL!

# MRC1 AND MRC2 REDUNDANT VFD SYSTEM & NEW SUBSTATION COMMISSIONED





In the esteemed presence of Kochi Refinery senior leadership and department representatives, Shri. Sriram S, CGM(E&AS), inaugurated the MRC1 & MRC2 Redundant VFD Systems and the new MRC2 (DN2) Substation Building on 03 May 2024. The new facilities were commissioned as part of the Kochi Refinery Business Plan target of improving MSBP reliability by providing redundancy to VFDs of Recycle Gas Compressor (MRC1) and Net Gas Compressor (MRC2) at an overall expenditure of around Rs. 12 Crores.

The system involved construction of a new air-conditioned substation, two new VFDs (6.6kV), two 6.6kV electrical switchboards and two PLC systems for running the 6.6kV 5.64MW MRC2 motor and 6.6kV 4.67MW MRC1 motor. The system is envisaged to provide better survival of MRC1 & MRC2 motors during power dips and change over to the redundant VFD in case of a failure in the running VFD, thus ensuring improved availability & reliability of MSBP plant.

The project was executed by E&C and was commissioned successfully during MSBP short shutdown in April 2024, by a multi-department team consisting of E&C, P&U-Electrical and Manufacturing. The new MRC1 and MRC2 VFD systems are the largest redundant VFD systems commissioned in India, by its respective OEMs (ABB & Hitachi).

# FOCUSING ON CONTRACTOR SAFETY

HSE Training is mandatory for contractors working with Kochi Refinery. Focusing on the safety of contractor community, Kochi Refinery has been progressively introducing various learning initiatives over the years. Mr. Mathew P Thomas, GM(HSE) I/c recently inaugurated the Height Pass Test facility which has been installed near the main entrance gate.

Regular trainings are organised for Contractor staff at the AMAS HSE Training Hall. More facilities are being added at the AMAS also to enhance the training support to contractor's staff.

a) Workplace PPE – Workplace PPE is the display of personal protective equipment (Helmet, Goggle, Earmuff, Coverall, Safety Shoe, Full Body Harness, BA set, Electrical equipment, Multi Gas Detector) which shall be used at workplace while executing the assigned job. Practical knowledge of personal protective equipment has brought out the clarity of PPE shall be accepted before the commencing the job at the site. Wearing the proper PPE at planed job is the commitment of Contractor's staff to finish the job without any personal injury to them.

**b) Life Saving Rules (LSR) –** Trilingual BPCL's 12 LIFE SAVING RULES (LSR)board fixed at AMAS HSE Training Hall. These rules are helping to identify the risk before and after an activity. Rules narrate the safety control system shall be practiced before undertaking and during the work.

c) Height Pass Test – The Height Pass Test facility installed near the main entrance gate. This facility was developed to check ACROPHOBIA (fear of height) for successfully executing the job at more than 1.8m height for the selected contractor's staff.

# PROJECT ASPIRE **CREATING VALUE FOR OUR STAKEHOLDERS IN THE NEXT 5 YEARS**

**KNOW MORE** 

Spearheaded by our Chairman & Managing Director Mr. G Krishnakumar, Bharat Petroleum is on a high voltage mission that aims at Doubling the Profits from 2021-22 and Quadrupling the Market Capitalisation in next 5 Years (2023-28). On his recent visit to Kochi Refinery, C&MD launched Project Aspire, which is built on the eight pillars namely Refining, Marketing, Non-Fuel, Gas, Upstream, Petrochemical, Green Energy Business and Digital Ventures.

The four broad themes of Project Aspire are to (1) Nurture and grow BPCL's current core businesses; (2) Make 5 big bold bets in Gas, Non-Fuel, Petrochemicals, Green Energy and Digital Ventures; (3) Strengthen Foundational elements of R&D, Funding, Digital and Partnerships and (4) Strengthen the organization and invest heavily in Talent development.


People, R&D, Partnerships, Funding Excellence, Digital, Technology & Innovation are the key drivers to achieve the aspiration mentioned in the eight pillars, which we will be addressing one by one in the Know More series. Lets take a closer look at the green energy business.

#### FUTURE BIG BETS

#### **GREEN ENERGY BUSINESS**

BPCL aims to build 10 GW of renewable energy portfolio through organic and inorganic acquisition of operating assets, by 2040. The clean energy business will include producing green hydrogen, which emits only water when burnt. As shared by our C&MD, "We will produce 30,000 tonnes per annum of green hydrogen in our refineries by 2030, to meet 10 per cent of our hydrogen demand. We will also engage in pilots for green hydrogen fuelled mobility and other applications.

We are also aggressively pushing for biofuels and plans to set up 26 compressed biogas plants in the near term. "In the EV charging business, we plan to reach a total of 7,000 EV charging stations by FY25. As of March 2024, we added 2,443 new EV charging and battery swapping stations, taking our total to 3,135 EV charging and battery swapping stations," C&MD said. The EV charging stations will complement the fuel retailing network which also includes 2,034 CNG stations.
